Definitions

Provider Country

The UK country of the UCAS Teacher Training provider. The country may be England, Wales or Scotland. See the additional technical notes at www.ucas.com for coverage and trends for Scotland.

Applicant Domicile (High Level)

Applicant's area of permanent residence summarised by individual UK country. This variable is derived from domicile as declared by the applicant. Split by the following values: 'England', 'Northern Ireland', 'Scotland', 'Wales'. Please note: The Channel Islands and the Isle of Man have been assigned as 'Not EU'. See the additional technical notes at www.ucas.com for coverage and trends for Scotland.

Acceptance route

Apply route through which an applicant was accepted. Applicants may make up to three applications through Apply 1 and one application at a time through Apply 2. Applicants can also be accepted through a Record of Prior Acceptance (RPA).

Cycle Year

The application year in which the application was processed.

Acceptances

An acceptance is defined as an applicant who has been accepted to start a programme through the UCAS Teacher Training scheme.
