

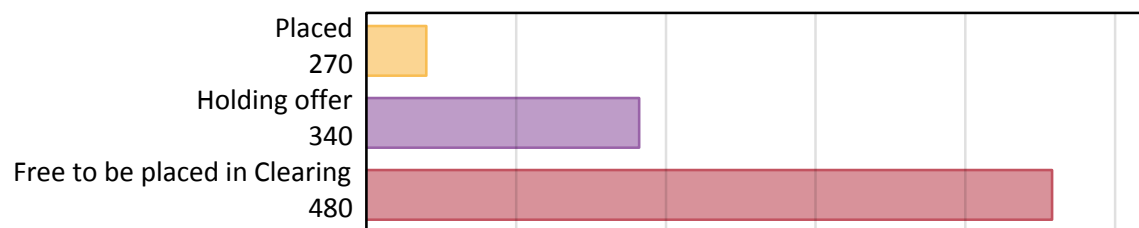

Nursing applicants at SQA results day. Applicants who applied to nursing but who are placed at, or holding offers solely to, non-B7 courses are not included.

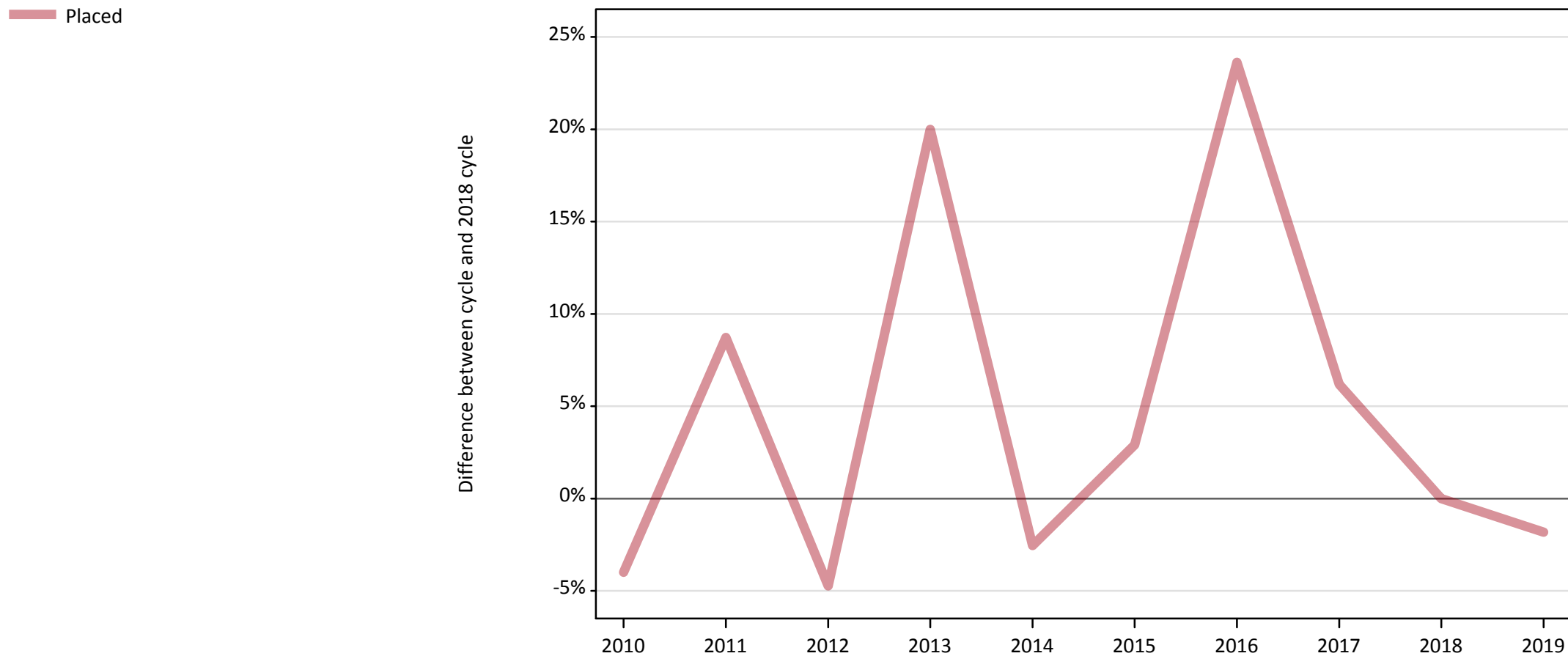

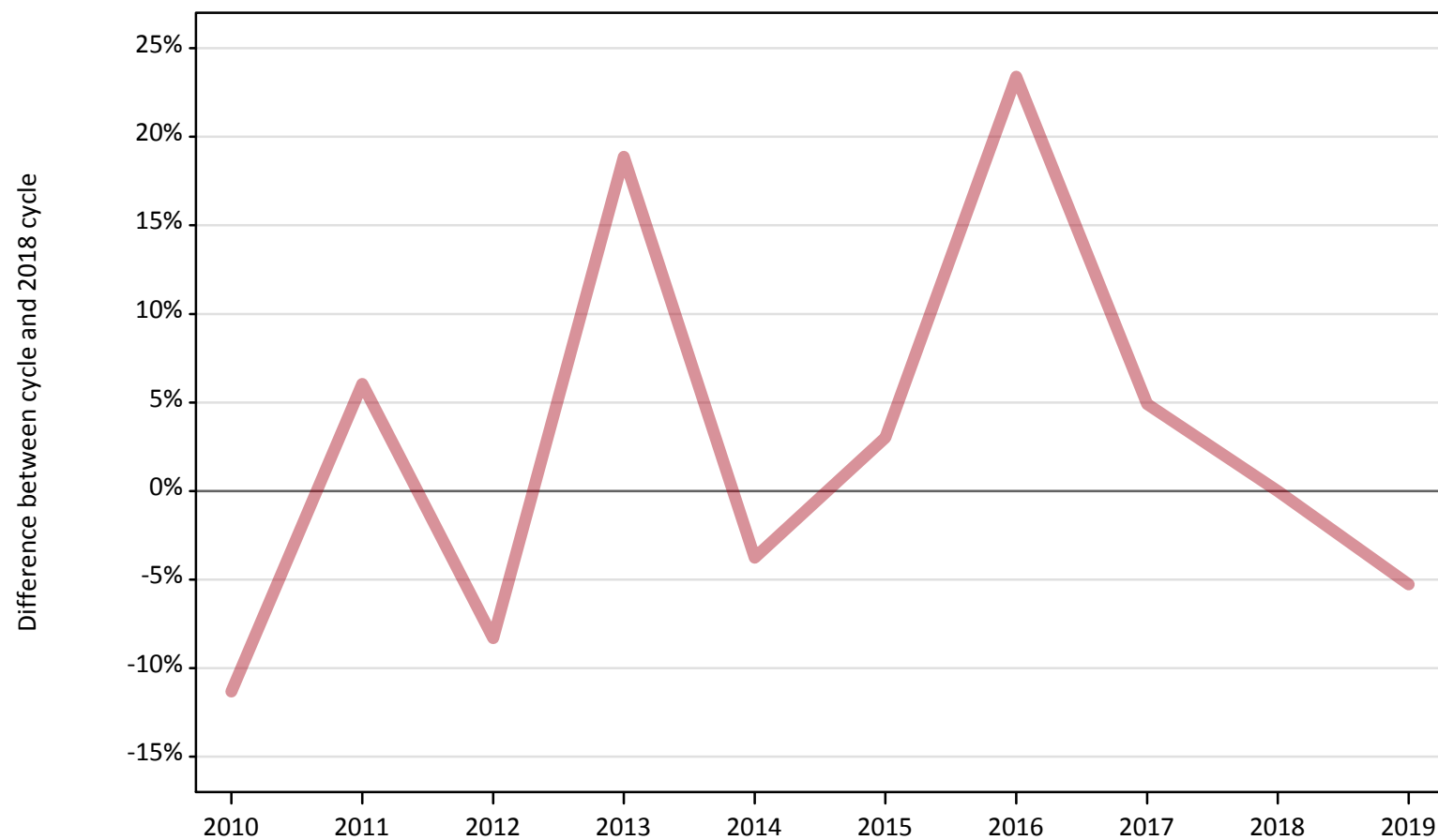

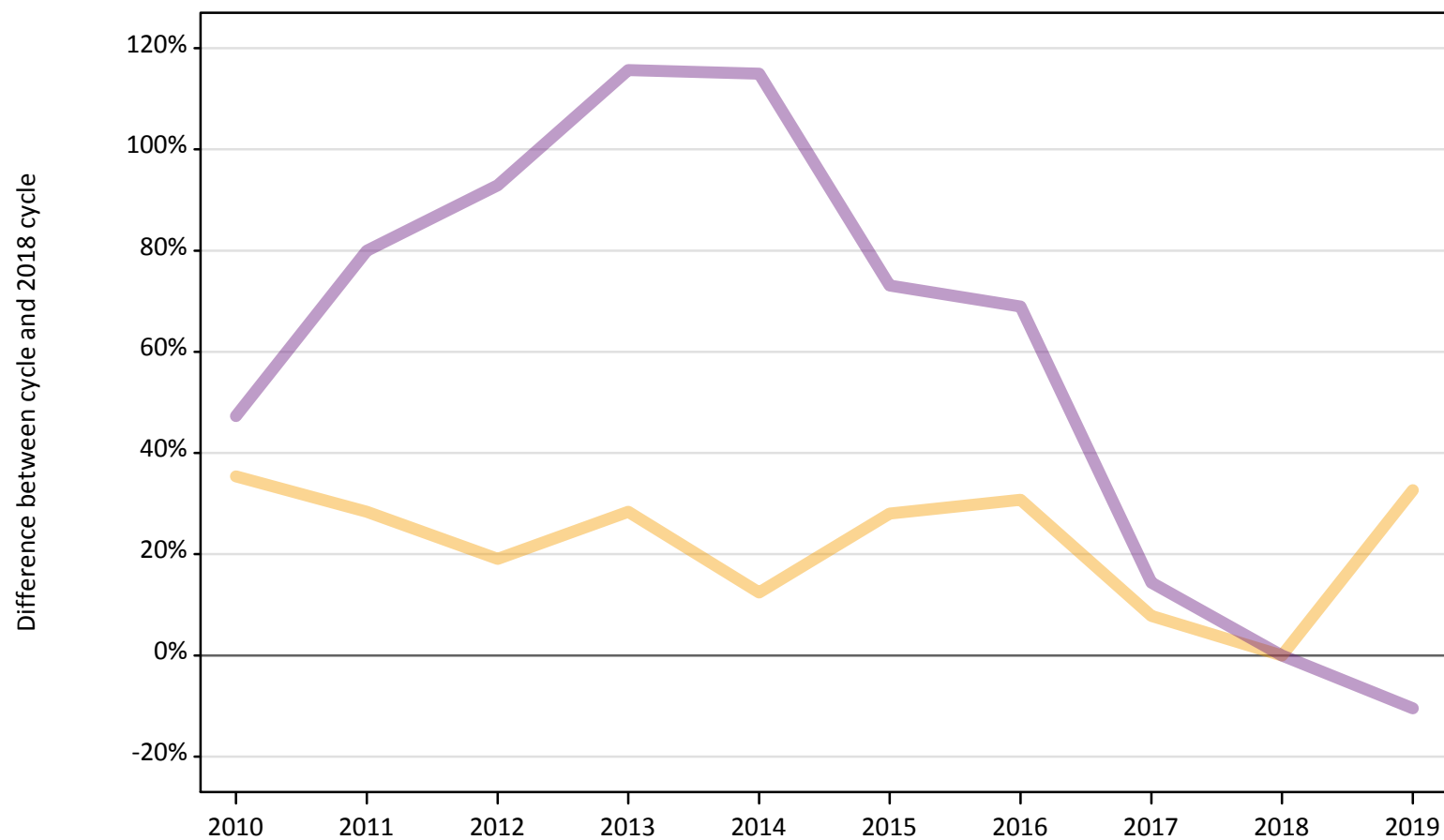
