Accidents and near misses

If you are involved in, or witness, an accident or near miss while on-site, please report it to the organisers, who will be at the general information desk in the hall.

Arrivals

When you arrive, please head to the entrance of The Royal Cornwall Exhibition Halls and have your ticket ready for inspection. If you don't have a ticket, please report to the registration desk.

Your exhibition ticket is personal to you and should not be passed on to other group members, as this would compromise the security of your data. To comply with data protection regulations, it's essential individuals at our exhibitions use their own ticket — both on entering, and when visiting exhibitors' stands. Anyone found to be in breach of this will be asked to leave the event and register again to gain readmittance.

C

Cars

There is free parking available on-site. Please follow the direction of the traffic marshals, and enter the site through the main entrance, where they'll direct you to the designated car park.

Cash machines

There are no cash machines on-site.

Catering

There will be refreshments for all visitors in the exhibition hall, and a small seating area for all to use.

Coaches

If you're travelling by coach, please enter the site through the main entrance, and traffic marshals will direct you to the coach drop-off and pick-up area. Please make sure students



know what time and where to meet for their return journey. Due to the expected number of visitors, please don't arrive any earlier than 15 minutes before your booked session time.

Directions

Directions by car and coach

The venue is approximately 1.5 miles from Wadebridge town – please follow signs along the A39. You can also use postcode PL27 7JE on a satnav.

Directions by rail

The nearest train station is Bodmin Parkway, approximately 12 miles away. Taxis and buses are available from the station, but it may be advisable to book a taxi in advance.

Emergency procedures

Please ensure you're familiar with the procedures to be followed in an emergency at the venue. In an emergency, please make your way to the nearest exit and follow the instructions of the security staff.

Event staff

For general queries during the event (e.g. directions to facilities), ask any of the event staff, who can be identified by their red UCAS t-shirts.

First aid

There will be a first aid team on hand during the event – if you require assistance, please ask a member of event staff to alert a first aider, or come to the organiser's office/help desk.
