## C.6 Technical notes and definitions

UCAS Teacher Training (UTT) provides a single admissions system for higher education, SCITT-based, School Direct, School Direct (salaried) and PG Teaching Apprenticeship courses.

This report covers the changes in applicants to UTT courses.

Applicants have been able to submit applications for all 2021 UTT courses since 13 October 2020, whilst the 2020 cycle opened on 08 October 2019.

Differences in the calendar between the two cycles, for example movement of bank holidays, could affect figure comparisons by week.

From the 2015 cycle onwards, teacher training courses for Scottish providers are included within the UCAS Undergraduate scheme and are reported there.

The reference point for the 2020 cycle data in this report is 00:06 on Monday 23 December 2019.

Values have been rounded to the nearest 5. This may result in instances where totals do not equal the sum of the components.

Categories of a variable are only displayed if the value is larger than zero in one of the columns in the relevant row, after rounding has been applied. Therefore, there may be some categories of some variables which are not displayed.

### Age

This report uses country-specific age definitions which align with the cut-off points for school/college cohorts within the different administrations of the UK. For England and Wales, ages are defined on 31 August, for Northern Ireland on 1 July, and for Scotland on 28 February of the following year. Defining ages in this way matches the assignment of children to school cohorts. For applicants outside the UK, the cohort cut-off for England and Wales has been used.

### Applicant

A person who has made an application to UTT during the cycle reported.

### Applicant status

Applicants have been assigned to a summary status based on their applications. If an application is made in Apply 2, the applicant is only counted within Apply 2. The summary status is the highest ranking application's status from the following:

All states: all applicants.

Placed: applicants who have either firmly accepted an unconditional offer or had their place confirmed after meeting conditions of a conditional firm offer.

Conditional placed: applicants who have accepted a conditional offer as their firm choice.

Holding offer: applicants who are holding an unconditional or conditional offer which they have not replied to.

### Apply route

The route, Apply 1 or Apply 2, that applicants have applied through.

Applicants may make three applications through Apply 1 and one application at a time through Apply 2.

Applicants are reported under Apply 2 after they have made an application through Apply 2.

### Domicile

Declared area of permanent residence. The Channel Islands and the Isle of Man have been assigned as 'Not EU'.
