## Introduction

Functionality to allow UG applicants to release themselves into clearing by self-service was introduced for the 2019 clearing period. In 2020 we made enhancements to require the applicant to provide the reason for them doing so and a real time report was made available in the Weblink application.

For clearing 2021 we are enhancing the reporting with a separate view/method in odbclink/xml-link respectively similar to the report in web-link to allow higher education providers (HEPs) to identify the applicants that have used this functionality to give up their place with them. This view/method will capture the applicant's self-release decision and reason in real time and will not disappear when the clearing choice is substituted.

## **Solution Approach**

In odbc-link and xml-link, a new view/method will be available to provide the details of the applicants releasing themselves into clearing from their place with the HEP.

## **Technical Implementation**

- New Reporting method will be added to the xml-link webservice to report the selfreleased applicant details.
- New Reporting view will be added to the odbc-link database to report the self-released applicant details.
- The fields of the view/method will be similar to those currently available in web-link.
- Link Product manuals to be updated to reflect the new view/method details.
