C.6 Technical notes and definitions

UCAS Teacher Training (UTT) provides an admissions system for higher education, SCITT-based, School Direct, School Direct (salaried) and PG Teaching Apprenticeship courses. In January 2019, The Department for Education (DfE) released its new teacher recruitment and retention strategy. As part of this, DfE confirmed its intention to launch its own postgraduate teacher training admissions service in England. The pilot for this service went live in November 2019, with a continued roll-out during the 2020/21 recruitment cycle. The statistics in this report reflect changes in applicants to postgraduate teacher training provision via either the UCAS service or the DfE service, covering the majority of the sector.

Applicants have been able to submit applications for all 2021 postgraduate teacher training courses since 13 October 2020, whilst the 2020 cycle opened on 08 October 2019. This report covers applicants that have applied to any postgraduate teacher training course. Applicants who applied through both the UCAS and DfE services have had their duplicate removed from counts.

Differences in the calendar between the two cycles, for example movement of bank holidays, could affect figure comparisons by week.

From the 2015 cycle onwards, teacher training courses for Scottish providers are included within the UCAS Undergraduate scheme and are reported there.

The reference point for the 2020 cycle data in this report is 00:06 on Monday 27 July 2020.

Values have been rounded to the nearest 5. This may result in instances where totals do not equal the sum of the components.

Categories of a variable are only displayed if the value is larger than zero in one of the columns in the relevant row, after rounding has been applied. Therefore, there may be some categories of some variables which are not displayed.

Age

This report uses country-specific age definitions which align with the cut-off points for school/college cohorts within the different administrations of the UK. For England and Wales, ages are defined on 31 August, for Northern Ireland on 1 July, and for Scotland on 28 February of the following year. Defining ages in this way matches the assignment of children to school cohorts. For applicants outside the UK, the cohort cut-off for England and Wales has been used.

Applicant

A person who has made an application to UTT or the DfE service during the cycle reported.

Applicant status

Applicants have been assigned to a summary status based on their applications. If an application is made in Apply 2, the applicant is only counted within Apply 2. The summary status is the highest ranking application's status from the following:

All states: all applicants.

Placed: applicants who have either firmly accepted an unconditional offer or had their place confirmed after meeting conditions of a conditional firm offer.

Conditional placed: applicants who have accepted a conditional offer as their firm choice.
