A.11 Technical notes and definitions

UCAS Teacher Training (UTT) provides an admissions system for higher education, SCITT-based, School Direct, School Direct (salaried) and PG Teaching Apprenticeship courses.

In January 2019, The Department for Education (DfE) released its new teacher recruitment and retention strategy. As part of this, DfE confirmed its intention to launch its own postgraduate teacher training admissions service in England. The pilot for this service went live in November 2019, with a continued roll-out during the 2020/21 recruitment cycle.

The statistics in this report reflect applications to postgraduate teacher training provision via either the UCAS service or the DfE service, covering the majority of the sector.

Applicants have been able to submit applications for all 2021 postgraduate teacher training courses since 13 October 2020. This report covers applicants that have applied to any postgraduate teacher training course. Applicants who applied through both the UCAS and DfE services have had their duplicate removed from counts.

From the 2015 cycle onwards, teacher training courses for Scottish providers are included within the UCAS Undergraduate scheme and are reported there.

Values have been rounded to the nearest 5, this may result in instances where totals do not equal the sum of the components.

Age

This report uses country-specific age definitions which align with the cut-off points for school/college cohorts within the different administrations of the UK. For England and Wales ages are defined on 31 August 2021, for Northern Ireland on 1 July 2021 and for Scotland on 28 February 2022. Defining ages in this way matches the assignment of children to school cohorts. For applicants outside the UK, the cohort cut-off for England and Wales has been used.

Applicant

A person who has made an application to UTT or the DfE service during the cycle reported.

Applicant summary status

Applicants have been assigned to a summary status based on their applications. If an application is made in Apply 2, the applicant is only counted within Apply 2. The summary status is the highest ranking application's status from the following:

Placed: applicants who have either firmly accepted an unconditional offer or had their place confirmed after meeting conditions of a conditional firm offer.

Conditional placed: applicants who have accepted a conditional offer as their firm choice.

Holding offer: applicants who are holding an unconditional or conditional offer which has not been replied to.

Other: all other applicants who are not placed, conditionally placed or holding an offer.

Applicants are only counted in one group and against one route.

Applicant detailed status

Using the same methodology as the summary status, the detailed status is the highest ranking application's status from the following:

Placed: applicants who have either firmly accepted an unconditional offer or had their place confirmed after meeting conditions of a conditional firm offer.

Conditional placed: applicants who have accepted a conditional offer as their firm choice.

Unconditional offer: applicants who are holding an unconditional offer which has not been replied to.

Conditional offer: applicants who are holding a conditional offer which has not been replied to.

Pending provider decision: applicants who are waiting for a reply from a provider or have been invited to interview.

No current offer: applicants who have either been unsuccessful in their choices, declined their offers or withdrawn. This includes applicants who have received an offer but the offer was later retracted, for example if the applicant does not meet all required conditions.

Applicants are only counted in one group and against one route.

Applicant full status

Using the same methodology as the summary status, the full status is the highest ranking application's status from the following:

Placed: applicants who have either firmly accepted an unconditional offer or had their place confirmed after meeting conditions of a conditional firm offer.

Conditional placed: applicants who have accepted a conditional offer as their firm choice.

Unconditional offer: applicants who are holding an unconditional offer which has not been replied to.

Conditional offer: applicants who are holding a conditional offer which has not been replied to.

Interview request: applicants who have been invited to an interview.

Pending provider offer: applicants who are waiting for a provider decision.

Offer retracted or not made: applicants who have either not received offers, or have received an offer which was later retracted, for example if they did not meet the conditions of the offer.

Offer declined: applicants who declined offers they received.

Application withdrawn: applicants who have withdrawn their applications.

Applicants are only counted in one group and against one route.

If an applicant withdraws from UTT then all applications are treated as 'Withdrawn' in these tables.

Apply route

The route, Apply 1 or Apply 2, that applicants have applied through.

Applicants may make three applications through Apply 1 and one application at a time through Apply 2.

Applicants are reported under Apply 2 after they have made an application through Apply 2.

Domicile

Declared area of permanent residence. The Channel Islands and the Isle of Man have been assigned as 'Not EU'.

Sex

Sex as declared by the applicant. The declaration is optional in the DfE service, with missing values and 'Prefer not to say' values being grouped together for reporting purposes.
