# **Background to qualifications reform**



Over the past ten years, a series of independent reviews expressed concerns about whether post-16 education supports people to enter good jobs and provides effective support for skills. The reviews found that many qualifications were not valued by employers, offered little value to students and had few routes to further education or meaningful employment.

The aim of qualifications reform was to simplify the qualifications landscape and improve both quality and progression outcomes


In 2024, funding was removed from qualifications that had less than 100 or no publicly funded enrolments for three consecutive years.

Last year, after the General Election, the Secretary of State for Education announced a short review of the reforms and a pause in defunding of qualifications due to be defunded in 2024.

The Review of Qualifications Reform affirmed a clear commitment to T Levels as a high-quality post-16 option, retained 157 qualifications previously identified to lose public funding, decided not to proceed with the proposed rules of combination and established a pragmatic approach to future reform, giving certainty until 2027.

# **Curriculum and Assessment Review final report**

- Recognised A levels and T Levels as strong academic technical routes, and recommended the introduction of a revised third pathway at level 3 called V Levels
- Emphasised the importance of reforming provision for those studying at level 2, who are likely to face additional barriers, and recommended the introduction of two separate pathways – an occupational pathway and a pathway to level 3
- On English and Maths, it reaffirmed, in line with current practice, that all learners who do not reach level 2 by the end of Key Stage 4 should continue to build the core knowledge, skills and confidence in English and maths.



# Post-16 Education and Skills Strategy

- Published on Monday 20 October
- Critical to supporting the development of a skilled workforce, delivering on our Plan for Change.

#### The strategy sets out proposals designed to:

- Introduce new 'V Levels' a new vocational level 3 option.
- Continue growing T Level provision.
- Strengthen post-16 level 2 options by creating two new dedicated pathways.
- Boost progress in maths & English.
- Make changes to the current accountability framework.




New, reformed Level 3 qualifications

# What are the new, reformed qualifications currently available?

- Level 3
- Alternative Academic Qualifications (AAQs).
- Reformed Technical Qualifications Technical Occupational Entry Qualifications and Additional Specialist Qualifications.
- 74 level 3 qualifications approved and published in May 2024 for first teach 1
   August 2025 and 66 for level 2.
- Available in subjects and routes aligned to Construction and the Built environment, Digital, Education and early years, Engineering and manufacturing and Health and Science.

#### Other level 3 training and qualifications

#### **Advanced Apprenticeship**

For learners seeking practical, workplace-based training, apprenticeships offer an alternative. Level 3 apprenticeships are also known as advanced apprenticeships.

**Other level 3 qualifications:** IB Diploma, Access to HE Diploma, Core Maths, Extended Project Qualifications. Performing Arts Graded Examinations, Advanced Extension Awards, Level 3 NVQ, Level 3 ESOL and Applied General Qualifications (AGQs).\*

\* AGQs will continue to have funding removed and you should continue to check when qualifications are available.

# **Alternative Academic Qualifications (AAQs)**

What are they?

## **Alternative Academic Qualifications (AAQs)**

- Level 3 qualifications
- Designed to support entry to higher education
- Minimum 60% mandatory core content, 40% external assessment
- Include elements of applied learning
- Small AAQs can be between 150 and 420 guided learning hours.

# **Reformed Technical Qualifications (1)**

What are they?

## **Technical Occupational Qualifications**

- Available at level 2 and 3
- Deliver competence against an occupational standard not covered by T Levels at level 3 for 16-19-year-olds and all occupational standards for adults.
- Aim to support a learner to enter, or to progress within, a role.
- At level 3, these can be any size

# Technical Occupational Additional Specialist Qualifications


- Available at level 2 and 3
- Specialist technical qualifications for post 16 learners and adults
- Go beyond the contents of an occupational standard
- Build on knowledge covered by a T Level or other occupational entry qualification at level 3.




# Next steps with HE

# **T Levels Update**

# T Levels are a high-quality route to skilled employment and Higher Education

- T Levels are high quality Level 3 qualifications designed to prepare students for skilled employment, higher apprenticeships, or further study.
- T Levels are built on occupational standards and include industry placements, giving students an early introduction to their future professions
- Through the outcomes of the Review of Qualifications Reform (12 December 2024) and the Post-16 Education and Skills Strategy (20 October 2025) **the government has asserted its commitment to T Levels** and ensuring more students have the opportunity to benefit from them.
- As T Levels mature, we are continuing to refine them to enhance deliverability whilst maintaining rigour and quality
- Offered by over 300 colleges and schools across the country, T Levels are now available in a wide range of subjects, including a new T Level in Marketing, taught for the first time from this September.

## T Levels cover 10 routes and 22 subjects

T Levels span a wide range of technical routes, each designed to meet industry needs and support progression into skilled employment or higher education. Below is the full picture of T Level subjects under each route.

## T Levels and UCAS tariff points

- UCAS has aligned T Level attainment standards with other level 3 qualifications, including A levels to support progression into Higher Education. UCAS points are awarded for the overall T Level grade, not individual components.
- T Levels will receive points in line with 3 A levels, such that the highest overall T Level grade (Distinction\*) will be awarded the same number of points as 3 A\*s at A level (168 UCAS points). An overall T Level Pass grade will be awarded at least 72 UCAS points, in line with 3 Ds at A level.
- UCAS will allocate points for partial achievement where a student completes the industry placement and one other component. This recognises valuable learning even if the full T Level is not achieved

## **Progression to Higher Education**

- The most common destinations of T Level completers is a university degree (44%)\*. In 2023 and 2024, 97% of T Level learners who applied for Higher Education through UCAS received at least one offer. For both years 83% of those who applied were placed.
- T level students are well prepared for their chosen course of study and they drop out at significantly lower rates than other learners \*\*
- T Level learners are more likely to work or study in the field of their T Level after completion than learners on comparable L3 qualifications (71% vs 61%)\*.
- More than 160 Higher Education Institutions accept T Levels for at least one course. DfE continue to work closely with sector bodies such as UCAS and UUK to ensure that T Levels are understood by HE providers as a high-quality offer.

#### Case study 1: Education and Early Years

Saman has a passion for childcare and has now successfully gone on to study an Early Childhood Studies degree at Staffordshire University upon completion of this qualification. Case study 2: University of Sunderland supports the progression of T Level students into higher education

The University of Sunderland treats T Levels as a mainstream route into higher education. In 2023, 22 T Level students joined degree courses in areas like nursing, computing, and primary education, supported by tailored taster days and guidance that make the transition smooth and successful. ## Post-16 Level 3 and below pathways consultation

- The creation of two new level 2 pathways:
   Further Study Pathway (Foundation Certificates) and Occupational Pathway (Occupational Certificates).

## **Level 3 Pathways - V Levels**



#### V Levels will:

- Provide a broad vocational pathway at Level 3...
- Be linked to employer-set occupational standards.
- Be the same size as A levels (360 GLH) so that they can be studied alongside A levels or other V Levels
- Have its content set nationally for improved consistency and quality, as it is for A levels and T Levels.
- Be rolled out between 2027 and 2030.

# **Example learner pathways**

#### Student A


2 V Levels and an A level

This student wants to get into either the creative arts or the media industry. They are interested in music and choose to do a mixed V Level/A level study programme. All qualifications are 360 GLH in size.

#### Student B

3 V Levels

This student is considering working in either the health or fitness industry but also wants to learn more about the digital sector as they know that digital could also support their future career aspirations and future business goals. All qualifications are 360 GLH in size.

# Further Study Pathway - Foundation Certificates

- For students who want, and are capable of, further study on a level 3 pathway, whether T Levels, V Levels or A levels, after an additional year at level 2.
- One year duration, 240GLH providing a balance of breadth and depth in a broad vocational area
- Strong focus on English and maths, alongside other enrichment activity and exposure to level 3 study
- Nationally set content
- Application of knowledge and skills to achieve practical outcomes, consistent grading scale

# Occupational Pathway - Occupational Certificates

- For students who want to enter a particular level 2 occupation and need to develop their technical knowledge and skills in a classroom-based setting, with the aim of progressing into skilled employment in relevant level 2 roles.
- Two year duration, with broad introductory content based on the occupational standards and set nationally, as well as occupationspecific content.
- Size driven by the relevant occupational standard no fixed GLH
- Tailored to support progression to work, including employability and enrichment activity.
- Strong focus on English and maths, including (where appropriate) the new "preparation for GCSE" qualifications

#### **V** Levels

- Provide broad, vocational qualifications for students who wish to explore a range of sectors.
- Comparable in size to an A level, V Levels can be studied alongside other qualifications such as English and maths.
- Blend applied learning with practical assessment, and their content will be linked to occupational standards set by Skills England.
- Enable progression to higher education, apprenticeships, or employment.
- Offer breadth for students who would like to explore sectors without specialising.

#### **T Levels**

- The main technical route for students who know which broad career area they want to pursue
- A single, large qualification equivalent to three A levels
- Aligned to employer-based standards
- Include a 45 day industry placement
- Combine sector-specific core content with a specialist component that develops competence in an occupation
- Enable progression to higher education, higher apprenticeships, or skilled employment.




## **Transition to new landscape**

- Government commitment to enable more students to benefit from reformed qualifications as soon as possible
- Phased rollout (2027–2030/31)
- Route-by-route approach
- Delivery certainty
- Transition planning



# Level 3 Pathways – T Levels and A Levels

T Levels continue to grow and will be the main technical offer for students who have a clear idea of broad career area they want to pursue. T Levels, aligned to employer-based standards and with a 45 day industry placement, are providing positive outcomes with students progressing to further study or employment.



Positive outcomes

- T Level are more likely to agree their course prepared them for the workplace than students on comparable L3 qualifications.
- T Level learners are more likely to work or study in their field than comparable L3 quals (71% vs 61%)
- **2/3** of T Level students who do apprenticeships after do higher or degree level apprenticeships higher than for level 3 learners generally.
- 1/3 of students get a job with their industry placement employer.



Accessible

- Young people with a range of prior attainment are accessing T Levels the GCSE grade split for students receiving T Level results is very similar to those receiving results for Applied General Qualifications (AGQs).
- Working with T Level providers and AOs to ensure content and assessment is accessible.



 A levels continue to be offered for students who want to pursue an academic pathway at university and are not in scope of this consultation.
