Dear

Not everyone gets a place on results day, and that's why we have Clearing. If you find yourself in this situation you may need to research courses and make a number of phone calls in a short period of time. This year we're introducing a new service that may help you.

It's optional, but if you sign up to the new service, it will allow universities and colleges to contact you from 13 August until 4 September if they have places on courses that are relevant for you – but only if you're eligible for Clearing.

Here's how it works.

- 1. You sign up for this service now by clicking on the Yes button below.
- **2.** From 13 August until 4 September, if you haven't got a place and are eligible for Clearing, this service will allow us to provide up to five relevant universities and colleges with details of your entire UCAS application. We'll select these universities and colleges based on your application and the applications of students these courses have previously accepted.
- **3.** These universities will then be able to contact you by phone if they have vacancies on courses that are suitable for you. If you're offered a place you can choose whether or not to accept it, as with any offer made through <u>Clearing</u>.

Even if you sign up to this service you may not be contacted by any universities and colleges if they don't have suitable vacancies. So if you're in Clearing you should still proactively search for Clearing vacancies using our <u>search tool</u>.

Once you've accepted a place, your name will be removed from the database and you won't be contacted by other universities again under this service.
